In 2018, 1,101 families received help through a total of 5,699 adult visits and 1,098 childcare visits. Alpha Grand Rapids provides four main types of services: medical, support, educational and material resources. In 2018, the Medical Services department provided 220 pregnancy tests, 96 ultrasounds for abortion-vulnerable women and 17 STD tests. The Support Services department offers one-on-one mentoring (for women) and coaching (for men) through the Step Up Program, group learning and encouragement through the Single Moms Support Group and haircuts through the on-site salon. In 2018, there were 2,968 hours of one-on-one mentoring and coaching as well as 229 "emergency visits" for clients who were out of necessary resources such as diapers and formula. Continued on Sch O
